## **Hello EVPA Members:**

Here are the minutes from the last EVPA meeting on March 15<sup>th</sup>.

- The meeting was brought to order promptly at 7:30pm
- The minutes from the February 15<sup>th</sup> meeting were approved.
- The Pink Triangle Park update was given by Herb Cohn who reported that the memorial committee was deciding upon one of five designs submitted to the committee, and that decision was expected in the next week or so.
- Heide Chipp gave the Treasurer's Report.
- Erin Day and Scott Larrime reported that permission from the SF Planning Commission on the planned remodel of their home at 4616 18<sup>th</sup> Street had been denied, and they asked for support from individuals in the EVPA membership. Erin and Scott can be contacted via email.
- Thomas Landry from the Ark House at 2500 Market Street introduced himself and took some brief questions regarding the notification of local residents and merchants. It appeared to some that notification came too late, since the program had opened the previous day. More information can be found on the 2500 Market Advisory Board web site at. Additionally, the Neighborhood Advisory Board meets every other Thursday at LYRIC, across the street from the EVRC. Neighbors and other interested parties are welcome to attend these meetings.
- The folks from CPMC presented the beginnings of their plans to reorganize their facilities during the planned seismic retrofit of their hospital network to take place over the next several years. It is proposed that Davies Medical Center house their acute care facility, but will have no helipad for trauma care. During the retrofit process, the hospitals must continue to provide care, so their existing facilities will need to be allocated during this time. This plan is still in its infancy, and they are looking for input from the community. Ann Mosher of CPMC can be contacted for further information at 415-923-3921.
- Judy Hoyem, a long-time EVPA member, gave a five-minute presentation on the developments in the ongoing saga of the abandoned Victorian at 4038 17<sup>th</sup> Street. The developer has presented a new proposal to the Planning Commission that completely demolishes the existing building, expressly against the previous ruling by the Planning Commission. Brett Gladstone, an attorney representing the developer of the proposed 3 condos that will replace the Victorian at 4038 17<sup>th</sup> Street, spoke for a short time regarding the plans. A motion was made to write a letter strongly supporting the previous ruling by the Planning Commission, as well as assigning this issue to the newly-formed EVPA Planning Committee for further study. The motion passed and Corresponding Secretary Gustavo Serina will write a letter expressing the wishes of the EVPA.
- A motion was made to require the newly formed committees of EVPA to have EVPA Board members as committee chairpersons.
   This motion passed.
